**Application for Registration as a Grower  
of Flue-Cured Virginia Tobacco**

**Notes**

1. Every grower (as defined in the Act) of flue-cured Virginia tobacco is required to register in respect of every tobacco crop to be grown.
2. The period of registration is for the 12 months ending on the 31<sup>st</sup> October in each year. Application for registration must be made after the 1<sup>st</sup> January and before the 31<sup>st</sup> October prior to the period for which application for registration is being made. Application for registration made outside of these dates render the applicant liable to pay a late registration fee as provided for in the Tobacco Industry and Marketing Rules 2000 as amended.
3. When completed, this form must be returned to the TOBACCO REGISTRATION OFFICE at either Regional Centres or at HQ-BOKA Tobacco Auction Floor, BOKA complex or post to P O BOX 10214, HARARE.
4. Additional copies of this form and also the application forms for registration as a grower of all other classes of tobacco (e.g Burley Tobacco and Oriental Tobacco) may be obtained from the registering offices mentioned in paragraph 3 above.
5. **REQUIREMENTS TO REGISTER AS A GROWER:**
  - i. Recommendation letter from the grower's local AGRITEX officer to confirm that the grower is a *bonafide* tobacco grower
  - ii. Proof of land availability i.e. permit/land offer letter Or a recommendation letter from the growers local Councillor/Chief if in communal area
  - iii. National Identification(original/certified copy)
  - iv. Registration fee payable on submission of the form(in terms of Section 26 of the Act).A late registration fee will be charged for registrations done after the deadline date(31 October of every year)
